There has been a review of the Governor Advisory Group and they had their last meeting last week. Governance Advisory Panel (GAP), a virtual panel through the Knowledge Hub will take it's place. This will hopefully widen the recruitment of governors to the Panel and get more comments on any proposals. GAP will meet twice a year.

### **Annual Child Protection and Safeguarding monitoring report**

The Annual Child Protection and Safeguarding monitoring reports for HW, Som and St H's were presented to the governors. The Chair signed the reports.

Child Protection was discussed; the EHT will deliver a Child Protection training session once a term for staff once a year.

Governors should attend an annual update on Child Protection. A governor commented that there are good online providers for Child Protection and Prevent training.

The EHT and **BE** will attend the Child Protection Overview course on 29<sup>th</sup> September and will update the FGB following attendance.

## Any Other Business (previously raised with the clerk)

- Bluntisham planning application for 135 houses opposite St Helen's school. Following the conditions survey at St Helen's the EHT contacted Bidwells to discuss what the new development could mean for the school.
  - The EHT wrote a letter of support for the development to HDC and copied to the Parish Council. The EHT has received 2 emails from the community disagreeing with her support. Governors have been made aware in case they are approached by members of the community. Several governors commented that the EHT has shown strong leadership and agree with the letter.
- There is another planning application submitted for a development opposite Budgens in Bluntisham.

- A planning application for 120 houses on Bluntisham Road, Needingworth has been submitted. The Parish Council have asked for any comments the school may have and are holding an Open Public meeting on Monday 18<sup>th</sup> September 2017.
- There is a proposal for all Children Centres to close next year. The CC are holding a
  consultation with the centres and the public. If the Children's Centre closes at Somersham
  school the CC will sign the building over to the school. The Clerk to add this to the Finance &
  Premises agenda. ACTION AJ
- MS has sent log ins to all governors for the new portal, when everyone has responded to MS
  and successfully accessed the portal correspondence will be sent through the portal. The
  Clerk will notify governors of the date that the switch will take place. ACTION AJ
- A governor commented that they recently attended an ISO audit where the move has been
  made to provide hyperlinks to model policies and queried whether there was an opportunity to
  reduce the workload of policies and be able to hyperlink from our website to model policies.
  The Chair responded there is a list of statutory policies each school must have.
